

# PURCHASERS AGREEMENT

## PURCHASER ACKNOWLEDGES:

1. A \$400 non-refundable deposit is required to reserve a Bengal kitten. This amount will be deducted from the price of your kitten. This cannot be transferred to a different kitten once reserved. We allow 48 hours to those that are interested to send their deposit. If not received by that time, the kitten/cat will be offered to a different interested family.
2. We require all Bengal cats/kittens that are purchased as pets to be spayed or neutered before going to their forever home, **NO EXCEPTIONS**. Pet price includes spay/neuter.
3. If a female Bengal kitten is purchased with full breeding rights, the buyer must agree not to breed her before she is 10 months of age. If a male Bengal kitten is purchased as a breeder, he must be sold to an established and serious breeder only. Further specifications will be addressed at that time.
4. The kitten will be guaranteed for a period of **48 hours** after leaving our home. We recommend that you take the kitten to see a licensed veterinarian before that time period is up. If a non-treatable condition is discovered, you must return the cat/kitten for another cat/kitten of equal value when one is available at seller's discretion. Proof of diagnosed condition must be presented.
5. This cat/kitten is guaranteed against congenital defects for **12 months**. Should the cat die within that time frame, the cat will be replaced, **ONLY** if a licensed veterinarian performs an appropriate necropsy and a vet's certificate is provided as proof of cause of death. A replacement cat of comparable quality and value will be made available at the breeders' discretion and availability. There are no guarantees on future health, reproduction capabilities, and temperament or show achievements.
6. We do not guarantee against treatable non-life threatening nuisances that could arise (ear mites, fungus, yeast, respiratory infections, parasites, etc.). Once the kitten leaves with the buyer, the buyer is responsible for all vet bills. **DO NOT** allow Ketamine to be used on them. Bengals do not do well with this drug. Do not expose him/her to poisons such as poisonous plants, over the counter flea collars etc. Bengals are more sensitive to chemicals.
7. It is recommended that your new Bengal kitten/cat be quarantined for **2-4 weeks**. Gradually introduce the cat/kitten to other animals and family members. We are not responsible for any injury that may be caused to buyer/anyone else after the kitten is purchased. Any animal can scratch, bite, claw, chew, spray, etc.
8. Buyers understand that cats/kittens can experience Upper Respiratory Infection due to the stress of moving.
9. If buyer or seller commences any legal action as a result of this contract, Buyer agrees that the place of venue shall remain in the County of Page in the State of Iowa. This contract is a legal and binding agreement between the two parties (buyer and seller) and is **NOT** transferable.
10. Seller does not guarantee against FIP in your kitten. FIP comes from a mutation of a feline intestinal virus (FECV) and no one can pinpoint when or where a cat was exposed and at what point it mutated into FIP. Some cats are exposed to FECV and never develop FIP. The current means of testing for FIP has a high rate of false positives. Also, if you vaccinate against FIP the test for FIP will always come back as positive even though your kitten may not actually have the disease.
11. No history of HCM in breeders, all kittens guaranteed clear of PK, DEF and PRA. Breeder kittens guaranteed with paperwork to verify to be NN on PK, DEF and PRA as requested.
12. Under most cases you will pick up your kitten or arrangements to meet will be made. In rare situations where transport is arranged, costs are to be added to the selling price.
- 13. Payment through PayPal, Venmo or cash only.**
14. Breeder guarantees that the cat listed above is a purebred Bengal cat, with an accurate pedigree, and is eligible for registration with The International Cat Association (TICA).
15. Kittens are home raised. They are not ready for adoption until 10-12 weeks of age. When placed, they will have all necessary vaccinations, a Vet examination, de-wormers, a health certificate, TICA registration form, and will be spayed/neutered if a pet.
16. We do not allow visits before the kitten is 8 weeks old, when they have had their first set of vaccinations; this is to keep them healthy.
- 17. Declawing kittens will void health contract.**
